Review includes comparison to compensation for similarly qualified persons in functionally comparable positions at similarly situated organizations, that is, CEOs of other nonprofit organizations of similar size and scope, as well as to national benchmarks. Contemporaneous substantiation of the deliberation and decision is accomplished via documentation of reports and responses of the committees in meeting minutes, as well as notification of the full board in board meeting minutes.
