The process for determining compensation of the CEO includes review and approval by independent persons, specifically Horizons Board Personnel and Compensation Committee and the Board Executive Committee. Review includes comparison to compensation for similarly qualified persons in functionally comparable positions at similarly situated organizations, that is, CEOs of other nonprofit organizations of similar size and scope, as well as to national benchmarks. That information is reviewed by the Committees and their decision regarding CEO annual increase/bonus is brought to the full board for vote in an executive session of the board.
